Stream supports over 12,000 users, 175 hospitals and research sites, and more than 300 industry sponsors. Have you heard about Ontario's new **Universal Agreement for Clinical Trials** (UACT)? This standardized clinical trial agreement was developed collaboratively with hospitals and industry to simplify contracting, reduce negotiation burdens, and provide greater consistency for both sponsors and sites. Already adopted by 21 hospitals and global sponsors, it's part of CTO's new **QuickSTART** program to improve efficiencies and collaboration, with a goal of activating clinical trials in just 45 days.
